- 2) AREA OF OPERATION :- Maharashtra
- 3) ACCOUNTING YEAR: The financial year of the society shall be 1<sup>st</sup> of April to 31<sup>st</sup> March of every year.
- 4) MEMBERSHIP AND PROCEDURE OF ENROLLMENT :

Only the former students can be the member of the society. However the current students of the Institute who are in the final year can become member of the association. Who agree with the aims and objects of the society should apply in prescribed form for becoming member of the society. They shall have to abide by the Rules and Regulations of the said society. Every person applying for membership will be requested to pay entrance fee of Rs 200/- Membership will be allowed after सार्वजनिक न्यास नोंदणी कार्यालय nsideration and approval of Managing Committee. Managing Committee keeps the नाशिक विभाग, नाशिक right to reject any application for membership by giving specific reason.

- 5) KINDS OF MEMBERSHIP:-
  - A) LIFE MEMBER: A person who pays one time Rs.100/- for life time shall admitted as Life Member.
  - B) Annual Member: A person who pays Rs.50/- per year shall be admitted as Annual member.

#### DISQUALIFICATION/TERMINATION OF MEMBERSHIP :-

- a) A person shall ispo-facto cease to be a member and shall be removed as such by the Managing Committee.
- b) On his/her death.
- c) On his/her resignation of membership
- d) On he/she convicted of criminal offence.
- e) If he/she fails to pay his/her subscription for consecutively more than two year
- f) If he/she breaks the rules and regulations of the society.

7) ANNUAL GENERAL BODY MEETING, ITS POWER AND FUNCTIONS:-

The General body meeting of the society shall be held once in a year within 90 days immediately after 31st march of every year at such place, time and date which Managing Committee shall determine.

- To confirm the minute of the previous Annual General Body Meeting. I)
- To adopt the previous year's audited statement and documents. II)

- III) To elect the Managing Committee for the next terms, if the term is over.
- IV) To admit new members as per decision taken by, the term is over.
- V) To appoint Advocate/Legal Advisor, chartered Accountant and fix their remunerations.
- VI) To consider any matter, due notice of which has been given by 15 days prior to the General Body Meeting.

#### 8) NOTICE OF GENERAL BODY MEETING AND QUORUM :-

- a) Notice of General Body Meeting: Fifteen (15) clear days notice specifying the place, date, time with agenda shall be given to the each and every member of the society, by hand delivery/by post (U.P.C) to their registered address.
- b) QUORUM of General Body Meeting: The Quorum for general body meeting shall be 3/5 of members of the society on record. Any adjourned meeting for want of quorum shall be held half an hour later at the same place and the members present shall form the quorum. But no business other than specified in the notice shall transact at such meeting.

#### 9) EXTRA ORDINARY GENERAL BODY MEETING AND ITS FUNCTIONS:-

An Extra Ordinary General Body Meeting may be conveying by the Managing Committee of its own motion, or upon a requisition made in writing by Chairman and/or 3/5 members of the society. Such requisition shall specify the subject of the meeting proposed to be called and must be signed by all the requisiteness and shall be delivered at the society.

#### 10) MANAGING COMMITTEE, OFFICE BEARERS:-

The management and administration of the said society shall be carried out and managed by the managing committee which may pay all the legal expenses incurred in promoting and registration of the said society, are mentioned herein these rules and regulations and specifically required to be exercised by the committee in general body meeting. There shall be minimum 11 and maximum 17 members in the Managing Committee at any time.

The Managing Committee shall be constituted of the following members Chairman-1, Vice Chairman-1, Secretary-1, Treasurer-1, and other members.

11) TERM OF MANAGING COMMITTEE AND PROCEDURE OF ELECTION OF OFFICE BEARERS:-

Tenure of the managing committee/Executive Board shall be five (5) years at a stretch and the new Managing Committee shall be elected in the Annual General Meeting of the Society. The Executive Board shall be continuing till the Executive board holds such election.

#### 12) OFFICE BEARERS OF MANAGING COMMITTEE AND THEIR DUTIES:-

#### 1) CHAIRMAN:-

- a) The chairman of the society shall preside over the meeting and regulate all the meetings of the Managing Committee.
- b) The Chairman shall in addition to his rights of voting as a member has a casting vote in case of tie.
- c) To conduct the meetings.
- d) To guide office bearers regarding day to day routine work of the society.
- e) To take final decision of receipt and pay of the society.

#### 13) NOTICE OF MEETING AND MANAGING COMMITTEE AND QUORM:-



The notice of the managing committee (Executive committee) meeting shall be issued by the Chairman/Secretary before 7 days, 2/3 members present in the meeting shall form a quorum of the Managing Committee. If meeting is adjourned for want of quorum, it shall be held an hour later at the place and members present shall form the quorum. But, no event any business that is specified in the notice be transacted in such meetings.

#### 14) RULES OF ELECTION OF MANAGING COMMITTEE:-

- a) The members of the managing committee will be elected after every 5 years in General Meeting.
- b) If necessary the existing Managing Committee will frame rules for the election.
- c) The Managing committee in existence has the right to choose the mode of election. If necessary, they can appoint the Election Officer one month before to the election.

#### 15) FILLING OF VACANCIES OF MANAGING COMMITTEE:-

If by death, resignation or otherwise or post of Managing Committee (Ex Council) happens to fall vacant, then the remaining members of Managing Committee will fill up that vacant place in their authority. If the post is vacant for more than six month, then the Hon'ble Charity Commissioner Nashik shall have right to fill up the said post.

#### 16) POWER AND FUNCTIONING OF MANAGING COMMITTEE:-

The Managing Committee shall work and have full powers and authority to do all acts, matter, things and deeds which may be necessary or expedient for the purpose of and in particular to the following.

- a) To look after, manage, supervise and control the management of the said society and its properties.
- b) To admit or reject new members and accept resignations of the members.
- c) To have an audited statement of accounts prepared every year for submission to the office of the Asst. Charity Commissioner and any other authority as may be required as the law for the time being in force, if any.
- d) To accept donation in cash or in kind in such condition and without condition.
- e) To appoint committee with such powers as the Managing Committee may think fit and proper, for such purpose and dismiss the same when the purpose is fullfilled.
- f) To make an appeal to the people for general donations as per the decision of the general body.
- g) Generally, to do all such acts, things as the incidental or conducive to the attainment of the above powers and duties or any one or more of them and the aims and objects specified in the Memorandum of society.
- h) To audits, accept and to receive consider the audited statements of accounts.
- i) To purchase, exchange, lease or hire or otherwise, howsoever and land building easements, rights of common privileges for the purpose of the society, providing that in the opinion of the managing body any condition attached to the gift or

donation is not onerous, against the object of the trust or in any other manner objectionable or in otherwise on order.

- j) To create or raise money as may be required for the purpose of the society, upon security bonds, debentures, promissory notes or other obligations or securities of the society or by mortgage or charge on the property of society..
- k) To create posts and make appointment on such terms as it may in its obsolete discretion, decide fill vacancies, direct transfers, retirements and give promotions, increments honorarium and grant leaves also extension of service to any officer or any employee of the society and to do all such acts and things may be necessary for the day to day working of the society.

#### 17) FUNDS AND INCOME OF THE SOCIETY OR ITS UTILISATION:-

Society shall raise their funds by way of subscription, Contribution, Membership fees, grants, bank interest, donation in cash or in kind etc.

18) OBJECTIVES BASED PROVISION FOR EXPENDITURE :-

The fund of the Society should be used for the fulfillment of the objects of the society as specified in memorandum of the Association and administration of the day to day activities of the Society.

#### 19) PROVISIONS FOR LOANS AND DEPOSITS

Managing Committee shall have power to keep society deposit in scheduled bank or nationalized Bank and also it shall have power to raise loans any banks or interest free loans from any individual body or in1stitution for the requirement or the society by taking prior permission of the Joint Charity Commissioner, Nashik.

# 20) PROVISIONS REQUARDING PURCHASE AND SALE OF IMMOVABLE PROPERTY :

The Management, achieving the target of the Society for administration of the Society at the Society shall sale or purchases an immovable property in name of the Society.

Society shall obtain the prior permission of the Joint Charity Commissioner, Nashik region to do and all the transactions shall be in accordance with the existing laws of the land.

#### 21) OPERATION OF BANK ACCOUNT AND OTHER FINANCIAL MATTER :-

All funds of the Society shall be held in any Nationalized or Scheduled Bank in the name of the Society. The Bank account of the Society will be jointly operated by and under the signature of any two of the following –a) Chairman b) Secretary c) Treasurer. The signature of the Chairman is compulsory in every transaction

22) MAINTENANCE OF REGISTER OF MEMBERS :-

This shall be as per the provision of sec.12 of Society Registration Act 1860.

#### 24) PROVISION FOR CHANGE IN THE NAME AND OBJECT OF THE SOCIETY:-

Name and / or objects of the Society shall be change / amended by minimum 3/5 of the votes of the members of managing body in any meeting and it shall be submitted to Charity Commissioner to obtain its sanction. It shall be as per the provision of according to sec. 112 and 12A of the Society Registration Act 1860.

#### 25) DISSOLUTION OF THE SOCIETY :-

Dissolution of the Society shall take place in accordance with sec. 13 and 14 of the Society Registration Act 1860. The Society can be dissolved minimum 3/5 votes of the members of the managing body, in any meeting.
